1. Sealed competitive tenders are invited by **Kerala Transport Development Finance Corporation Ltd (KTDFC)** from interested parties, firms or Companies, for the disposal of an office vehicle [Toyota Corolla (Petrol)], as per the terms and conditions mentioned herein. The Tender Document Set can be obtained from the Head Office of KTDFC or the same can be downloaded from the website **www.ktdfc.kerala.gov.in**. Tender Document is free of cost. Interested parties may submit their highest bids along with EMD in the appended proforma in a sealed cover addressed to the **“Chairman & Managing Director, Kerala Transport Development Finance Corporation Ltd (KTDFC), 6<sup>th</sup> Floor, Trans Towers, Vazhuthacaud, Thiruvananthapuram – 695 014”** and the same shall reach at the above address, either by hand or by post / courier, on or before **3.00 PM on the 19<sup>th</sup> April, 2021**. KTDFC will not be responsible for any postal/courier delay. No tenders received through email or any other electronic mode will be entertained. The cover should prominently be superscribed with the words **'TENDER FOR DISPOSAL OF OLD VEHICLE-TOYOTA COROLLA'**
3. The Tenders received in time will be opened at **04:00 PM** on the same day i.e. on the **19<sup>th</sup> April, 2021**. at the Head Office of the Company. The bidders or their duly authorized representatives, not more than one for each Tender, can attend if they so desire, at the time of opening of Tenders.
4. The Vehicle will be allotted to that Tenderer who offers the highest amount in the tender to the satisfaction of KTDFC as price of the vehicle. **However, KTDFC reserves the right to cancel the tender at any stage if it is found that the offers received are lower than the assessed basic value of the Vehicle.** The tenderers shall always have to

abide by the decision of KTDFC in this regard without any demur or protest.

5. The vehicle will be available for inspection during office hours till 2.30 pm on 19.04.2021.
6. The tender sale of said vehicle will be governed by the following conditions:\_
  - (A) Applicant shall remit an amount of Rs.5,000/- (Rupees Five Thousand only) as Earnest Money Deposit (EMD) for participating in the Tender.
  - (B) EMD shall be remitted by way of DD drawn from a Nationalized bank/Scheduled commercial bank in favour of the **Managing Director, Kerala Transport Development Finance Corporation Ltd** payable at Thiruvananthapuram.
  - (C) Tenders received without demand draft towards Earnest Money will not be considered and shall be rejected.
  - (D) The successful bidder shall deposit the bid amount by means of Demand Draft drawn in favour of the **Managing Director, Kerala Transport Development Finance Corporation Ltd** within two working days of the allotment of the tender.
  - (E) The Earnest Money of the successful bidder will be released only after the deposit of the bid amount and the change of ownership in the Registration Records of the vehicle with Motor Vehicle Department. Earnest Money will not be adjusted towards bid amount and the same will be forfeited, if he/she/it fails to honour the above conditions.
  - (F) The handing over of the vehicle will be permitted only after the successful bidder complies the conditions explained herein before including the submission of documentary evidence to prove address (Voter Identity Card, Aadhaar, etc, in case of individual and Registration Certificate etc., in case of firms).
  - (G) The vehicle can be removed by the successful bidder within 7 working days after complying the conditions stipulated in the preceding clauses, at his/her/their own expenses.
  - (H) The vehicle will be disposed off on '**as is where basis whatever there is**' basis. No guarantee or assurance is given by KTDFC of the road worthiness or quality

of the Vehicle. It shall be the absolute responsibility of the intending tenderers to inspect the vehicle thoroughly before submitting bids. KTDFC will not make any undertakings or promises regarding the vehicle.

- (I) The successful bidder shall also be responsible for getting the Registration Certificate of the Vehicle transferred in his name at his/her/its own cost expeditiously. KTDFC will not be responsible for any lapse on his/her/its part in this regard. It may be noted that current registration of the vehicle will expired on 26/04/2021. Hence it shall be the absolute duty and responsibility of the successful bidder to renew the registration of the vehicle after paying the required taxes and other expenses to the Motor Vehicle Department at his/her own cost and expenses, even if the finalization of tender proceedings by KTDFC is after the expiry of the registration of the vehicle. It shall be the absolute responsibility of the successful bidder to make the vehicle road worthy at his/her own cost & expense for getting the registration renewed. KTDFC will not take any responsibility in this regard.
- (J) The bids submitted by the tenderers shall remain firm and valid for acceptance for Six (6) months from the date of opening of the tender and the bidders cannot withdraw their bids before the firm period is over. In case of withdrawal of bid before the end of the firm period, the EMD will be forfeited.
- (K) The undersigned reserves the right to accept or reject any/all of the Tenders or to change the dates of tender, without assigning any reasons.
