If the selected Quotationer fails to carry out the work within the said period of 10 days , KTDFC shall be entitled to cancel the work order given to the Quotationer and forfeit the earnest money deposited by him/them along with the Quotation forms without giving any notice and without any obligation whatsoever and make alternative arrangements for the said work.

10. The earnest money of unsuccessful Quotationers, other than the second and third highest bidders, will be refunded within 7 days of the finalisation of the Quotation. As regards the second and third highest bidders, earnest money will be refunded within 7 days after the supply and installation of the item. No interest will be given on E.M.D.
