- 10. The earnest money of unsuccessful Quotationers, other than the second and third highest bidders, will be refunded within 7 days of the finalisation of the Quotation. As

- regards the second and third highest bidders, earnest money will be refunded within 7 days after the supply and installation of the item. No interest will be given on E.M.D.
